

# ASPIN's Opioid Workforce Expansion Program-Paraprofessional (AOWEP)

#### **Behavioral Health Education and Training Program**

### **Program Goals**

Indiana is in the midst of an opioid crisis, Emergency room visits for non-fatal drug overdoses in Indiana increased by nearly 60 percent in a recent five-year period, during which time deadly overdoses rose by an average 3.5 percent each year.

The ASPIN Opioid Workforce Expansion Program-

Paraprofessional (AOWEP) will expand the core CHW training to address the Opioid crisis in 10 Indiana rural counties: Huntington, Kosciusko, Marshall, Marion, Putnam, Sullivan, Decatur, Henry, Jefferson, and Howard.

Goal 1: Enhance the existing Indiana Certified Community Health Worker Paraprofessional Certificate Program by developing a New Opioid Prevention Treatment Recovery concentration for the Certified Community Health Worker Program.

Goal 2: Partner with Community Mental Health Centers, the Indiana Sheriffs Association, the Gateway to Work Program and other organizations to enhance community recruitment efficiency and increase hiring entity relationships for CHWs.



## **Benefits to Participants**

- Job growth for CCHWs nationwide is expected to be higher than average from 2014 to 2024. (U.S. Bureau of Labor Statistics)
- CCHW positions are expected to grow 15% faster than the average occupation. (Indiana Department of Workforce Development)

#### Helping to Address the Indiana Opioid Crisis Through Education and Training:

- I. Community Health Worker (CHW): 40 hours of online course/testing, Digital Self-study manual provided, All online with support from ASPIN instructors
- II. Opioid Basics for CHWs: 16 hours of online course/testing, All online with support from ASPIN instructors, Zoom/Skype facilitated study groups

#### **III. Field Placement-3 Options**

**Option One:** The student completes an 8-hour inperson field placement with a Community Mental Health Center. OR

**Option Two:** The student completes the 8 module on line virtual field placement with videos of counseling activities, virtual facility tours, telehealth practice exercises, and a review of administration procedures. OR

**Option Three:** The student's supervisor can attest that the student has work experience in behavioral health and completes the program checklist form for field placement credit.

#### IV. Jail Field Placement – 3 Options

As above except four hours at an Indiana County Jail that deals with Justice Involved Individuals with Opioid Use Disorder (OUD) and Substance Use Disorder (SUD).
